**POSITION SUMMARY:** Coordinates and administers functions relating to the process of foreclosures, post foreclosure claim activity, property preservation, and borrower account administration. This work requires direct contact with the public, the exercise of good judgment and the application of Tennessee Housing Development Agency ("THDA") policies and procedures as they relate to the application of payments, collection of amounts past due, loss mitigation, borrower counseling and other general customer service inquiries.

**ESSENTIAL DUTIES AND RESPONSIBILITIES**

Essential duties and responsibilities include the following. Other duties may be assigned.

- Communicates with team members on active efforts to prevent foreclosure or process foreclosure actions as required.
- Orders property inspections and valuations, reviews fees and costs associated with property preservations, prepares time line extension requests, monitors efforts to meet first legal date requirements.
- Handles communication with external partners on foreclosure actions, prepares files for mortgage insurance claim submission and documentation for audit purposes.
- Follows insurer guidelines for delinquent account management and collects documentation on foreclosure efforts to support account activity.
- Prepares and processes eviction requests, monitors loans for vacancy and property preservation.
- Prepares foreclosure bids, assists with deed in lieu, short sales or other property disposition alternatives.
- Assists with property preservation efforts, prepares properties for conveyance or transfer to Real Estate Owned (REO) management.
- Follows up on mortgage insurance claims, additional information requests and foreclosure sale results.
- Sets active follow up arrangements on accounts, records notes and financial data.
- Maintains and files electronic information to customer accounts with proper noting and documentation.
- Assists with all default processes.
- Assists with vendor management including notices of findings and scorecard reviews.
- Answers incoming phone calls and responds to customer requests for information on their accounts.
- Provides phone support through the Loan Servicing call center including incoming and outgoing follow up communications.
- Provides assistance with borrower counseling, loss mitigation processing and foreclosure avoidance.
- Provides assistance with mailing letters, forms or other customer contact.
- Assists with error resolution and customer complaint tracking.
- Provides back up for other Loan Servicing functions.

**MINIMUM QUALIFICATIONS**

**Education and Experience:**

- High school diploma or GED.
- Mortgage foreclosure experience.
- Telephone customer service experience.
- Successful completion of Mortgage Bankers Association courses in "Mortgage Servicing Basics Course" and/or "Conventional Foreclosure, Claims & Corporate Advance" preferred.
